HOMESTRETCH® HARVESTSHIELD™ COMPLETE is specifically formulated to protect and reduce yield loss of crops under abiotic stresses conditions such as drought, low or high temperature, deficient or excessive water, high salinity, heavy metals, and ultraviolet radiation.

### RATE RECOMMENDATIONS

Foliar application: Apply 1 q1/acre and repeat as needed. HOMESTRETCH HARVESTSHIELD COMPLETE is more effective if applied prior to stress events or during rapid vegetative growth stages. Application may also be beneficial during early to mid-flowering growth stages.

#### DIRECTIONS FOR USE

Fill mix tank with half of required water volume and begin agitation. Add products in this order, mixing thoroughly after each addition: adjuvants, pesticides, then fertilizers. Fill tank with remainder of water and continue agitation until solution is completely mixed. Check chemical mixture compatibility using a jar test prior to application.

**WARNING**: Product contains Boron and Molybdenum, Do not apply to Boron sensitive crops. Do not apply to crops that will be grazed by ruminant animals.
